Bylaw #32b – Amending; The Appointed Director, other than the Past Chair, shall take office immediately upon appointment and shall hold such office until their appointment by the Constituent Association expires. To The Appointed Director, other than the Past Chair, shall take office immediately upon appointment and shall hold such office for a minimum of two (2) years or until their appointment by the Constituent Association expires.

Bylaw #32c – Addition; The Chair Appointed Director shall serve a minimum of one (1) year.

3.0 Board Chair's Report

Fraser provided a synopsis of the past years' work done by the staff and board of BILD Alberta.

This fiscal year, we had 95% of members renew their memberships. This is a testament to the value of belonging to a three-tiered organization, demonstrating that our members support our advocacy work at each level. Your support has allowed us to continue to work on issues impacting members and be a trusted and respected voice for industry.

It has been an honour to have been Chair and worked alongside this talented group of board members and guided the association over the past year. Each board member has made a significant contribution that reflects the principles of BILD Alberta's pillars through their diverse backgrounds and skill sets. I look forward to seeing the work of this organization as it moves into the future.

4.0 Executive Director's Report

Scott reflected on the past year's achievements of the association and thanking the board for their support. Scott is looking forward to more industry leaders joining the Board and Councils for the year ahead.

5.0 Financial Report

a. Financial Status

Fraser de Walle presented BILD Alberta's statement for the fiscal year 2021-2022.

BILD Alberta designated three restricted funds last year totaling \$1,301,650.

The first of these restricted funds is an operating reserve of \$650,000 to provide for economic shifts, changes in membership or unforeseen operating conditions.

The second is \$350,000 for dissolution. This amount is set to ensure that any obligations of the association can be satisfied if operations ceased.

And finally, \$301,650 has been designated as a research and development fund. \$25,000 was removed to fund the Fortis Alberta Application for Advice and Direction on Streetlight Investment and will be returned when the final project is completed. We will continue to contribute to this fund as surplus allows.

Membership fees are recognized at the time of receipt to allow for various fiscal periods used by constituent associations. The fees recorded are based on dues received during BILD Alberta's fiscal period of July 1 to June 30.

The Deferred revenue amount is allocated to the 2022 Building the Future Conference. Registration and Award entry fees are collected prior to year-end and expensed in the month of September when the conference takes place.
